

Affiliate Program – Crosstrainer

We have the current licensing options outlined on a per user basis. Licensing options dictate the amount of users per copy.

How the Affiliate program works?

By marketing and selling the Crosstrainer in conjunction with us, you benefit financially without any added overhead of maintaining the actual software. You sell it; we provide customer support and upgrades to the software. The affiliate program is based on your sales performance level which is tracked through each licensed copy sold.

What is the Affiliate payout structure?

The Affiliate payout structure is listed below:

Affiliate Level	Affiliate Payout Structure
Sales per month less than 1000 USD	25%
Sales per month less than 5000 USD	30%
Sales per month over 5000 USD	40%
Sales per month over 10,000 USD	45%

*All totals calculated on a starting date period to ending date period.

*All totals calculated are before applicable taxes are applied.

*All payouts are in USD and payments will be issued at the end of the monthly period.

How does Crosstrainer Software Corporation track Affiliate Sales and money owing?

When an Affiliate is registered in our Affiliate program, we embed into the Crosstrainer software an Affiliate code which becomes part of the Registration System ID. This Affiliate version of the Crosstrainer software will be downloaded from the Affiliate's site and can be used for 30 days, during which, the customer has the option to register the software through the Crosstrainer Registration services. During the registration process, the selected License level and Affiliate information will be sent to Crosstrainer Software Corporation indicating that the software has been purchased and has become a fully registered copy. The Affiliate tracking information and level of license information is automatically entered into our license database which payouts are generated from. Payments will be issued no later than 30 days from the end of each monthly cycle.

Are there any terms or rules associated with this program?

- Crosstrainer Software Corporation sets the base pricing for Crosstrainer and all Crosstrainer related products. Affiliates are expected to honor this pricing structure. If Crosstrainer Software Corporation finds any deviations in pricing, effective immediately the Affiliate partnership with Crosstrainer Software Corporation shall be terminated and any future payouts shall be forfeited by the Affiliate.
- Monthly Affiliate payments shall be issued once the Affiliate account reaches 50 USD. Affiliate accounts less than 50 USD shall have their previous monthly statement carried forward to the next month and added to the next month's payment and will continue to until the account has reached 50 USD or more.
- Crosstrainer Software Corporation reserves the Affiliates right to limit the scope of advertising Crosstrainer and Crosstrainer related products outside an affiliate's own website. Crosstrainer Corporation must be notified previous to any Affiliate offsite promotions of any and all Crosstrainer Software and Crosstrainer related property.
- Crosstrainer Software Corporation and Affiliates both have the right to terminate the Affiliate program immediately without reason. Any outstanding balances shall be paid within 60 days of account termination. All account terminations are subject to review by Crosstrainer Software Corporation.
